The following policy statement from the American Psychological Association regarding deposit of NIH-funded authors' manuscripts in PubMed Central was downloaded on March 31, 2008 from <http://www.apa.org/journals/authors/pubmed-deposit.html> .

Basically, it says that the APA journals will deposit authors' manuscripts (not the "published" version) on behalf of the authors, if the authors fill out and submit the form (attached).

Also attached is a copy of the standard APA Publication Rights contract, with the clause relating to PubMed Central deposit highlighted:

"For manuscripts arising from National Institutes of Health (NIH) funded investigations, APA will send the final peer-reviewed and accepted manuscript file to the NIH manuscript submission system on your behalf, in a manner consistent with federal law. Please complete the form "Statement of Eligibility for NIH Deposit" in order for APA to identify relevant manuscripts."

The APA notes that deposit will occur 11½ months after publication, thus meeting the 12-month embargo limitation.

**Note:**

Authors wishing to disseminate their research sooner than 12 months after publication in an APA journal, should consider depositing the author's manuscript immediately in UNL's institutional repository: <http://digitalcommons.unl.edu> . APA policy allows this:

"Authors of articles published in APA journals may post a copy of the final manuscript, as a word processing, PDF, or other type file, on their Web site or their employer's server after it is accepted for publication. The following conditions would prevail:

- The posted article must carry an APA copyright notice and include a link to the APA journal home page.
- Further, the posted article must include the following statement: "This article may not exactly replicate the final version published in the APA journal. It is not the copy of record."
- APA does not permit archiving with any other non-APA repositories.
- APA does not provide electronic copies of the APA published version for this purpose, and authors are not permitted to scan in the APA published version."

## APA and NIH Enhanced Public Access

This notice provides important information about the NIH PubMed Central deposit request as it relates to articles published in APA journals.

The Policy on Enhancing Public Access to Archived Publications Resulting from NIH-Funded Research, notice number NOT-OD-05-022, was released on February 3, 2005 and took effect May 2, 2005. By this policy, NIH funded investigators are encouraged to deposit to PubMed Central (PMC) an electronic version of the final accepted manuscript within 12 months of publishers' final publication date.

**Deposit to PubMed is voluntary.** There has been some confusion in the research community that the NIH request is mandatory. This is incorrect. NIH officials have repeatedly stated that authors' participation is *voluntary* and that there will be no sanctions of any kind against authors who choose not to submit their manuscripts.

**The policy is prospective only.** NIH policy applies to NIH-funded empirical research accepted for publication after May 2, 2005. No material published and copyrighted with any scientific scholarly publisher prior to May 2, 2005 should be deposited in PMC, because of pre-existing copyright transfers and earlier legal understanding.

**APA will deposit appropriate manuscripts on behalf of the authors.** Authors publishing in APA or EPF journals, who wish to voluntarily deposit their manuscript in PMC, should NOT personally and directly deposit Word documents of APA published articles in PMC. As the copyright holder, APA will deposit the final accepted manuscript 11 1/2 months after the publication date of the article for manuscript appropriate for such deposit, upon request by the author. Complete and submit a PMC depositing request to APA Journals (PDF: 30KB).

**What version will be used?** The final "Word" version of the author generated manuscript after all changes based on peer-review editorial feedback and as accepted by the editor is the defined document NIH requests. APA retains this copy and will deposit it at the appropriate time. The final APA typeset article version as officially printed in the journal, which is fully copyrighted by APA, cannot be placed in *any* depository.

**What articles are covered?** The NIH policy **only** applies to empirical research journal articles—not book chapters, literature reviews, conference proceedings, or editorials.

**Major NIH funding is necessary for deposit.** For an article to be eligible for consideration for deposit in PMC, it is essential that NIH funding represent significant funding of the project. The clearest example of an eligible article would be one that is conceptualized and described in the original grant application. In general, an empirical report would be eligible for potential deposit if NIH provided meaningful and non-trivial funding of data collection and data analysis, and NIH should have provided significant salary support for the authors of the article. Incidental NIH funding is not sufficient NIH

## Information for Authors

U.S. copyright law requires that the transfer of copyrights in each contribution from the author to the APA be confirmed in writing. It is therefore necessary that you execute either Part A or Part C of the publication rights form on the reverse side of this sheet and return it to the Editor.

If your paper was prepared as a part of your job, the rights to your paper initially rest with your employer; therefore the Work for Hire section of Part B of the publication rights form also must be signed by an authorized agent of your employer.

Authors who are U.S. Government employees are not required to sign Part A of the publication rights form, but any coauthors outside the Government are required to sign Part A. However, if the majority of the authors or the primary authors are U.S. Government employees and the work was done as a part of their job, then the primary author should sign Part C of the publication rights form.

## APA Permission Policy Governing the Secondary Use of Copyrighted Material

It is the policy of the APA to own the copyrights to its publications, and to the contributions contained therein, in order to protect the interests of the Association, its authors, and their employers, and at the same time to facilitate the appropriate reuse of this material by others.

In exercising its rights under copyright, the APA makes all reasonable effort to act in the interests of the authors and employers as well as in its own interest. In order to do so, the APA requires the following:

1. The consent of author(s) be a condition to granting most republication permissions to others. In the case of a work made for hire, the employers' permissions will also be sought.
2. The consent of author(s) or employers as a condition to granting permission to others to reuse all or portions of the paper for promotion or marketing purposes.

Permission and fees are waived for authors who wish to reproduce their own material for personal use; fees only are waived for authors who wish to use their own material commercially (but for use in edited books, fees are waived for the author only if he or she is serving as the book editor).

Permission is not required for the photocopying of isolated articles for nonprofit classroom or library reserve use. A permission fee may be charged to the requester if students are charged for the material, multiple articles are copied, or large-scale copying is involved (e.g., for course packs).

A fee of \$25 per page, table, or figure is normally charged to all commercial organizations that secure permission to reprint APA-copyrighted material. This fee, after an appropriate deduction to APA to cover the costs associated with administering the permission function, is turned over to the American Psychological Foundation, a charitable nonprofit 501(c)(3) organization, incorporated independently of the American Psychological Association.
