## **CARLOS MUÑOZ, JR.**

**Carlos Munoz, Jr.** earned a Ph.D. in government from the Claremont Graduate School in 1973, and is currently a full professor in the Department of Ethnic Studies, University of California at Berkeley. He has gained international prominence as political scientist, historian, essayist and public intellectual.

Dr. Munoz was the founding chair of the first Mexican American Studies department in the United States in 1968 at the California State University at Los Angeles, and the founding chair of the National Association of Chicana and Chicano Studies (NACCS). He has authored numerous pioneering works on the Mexican American political experience and on African American and Latino political coalitions. His book, "Youth, Identity, Power: The Chicano Movement" won the Gustavus Myers Book Award for "outstanding scholarship in the study of human rights in the United States." This work was a major resource for the 1996 PBS television series "Chicano!: History of the Mexican American Civil Rights Movement."

Dr. Munoz is an acknowledged expert on the issues of ethnic and racial politics, multiculturalism, immigration and affirmative action. He has been interviewed by the MacNeil-Lehrer News and other PBS programs, NBS, CBN, ABC, CBS and the Spanish-speaking UNIVISION and Tele Mundo.

Since the 1960's he has co-founded or served as a leading organizer of various multiracial organizations including the Faculty for Human Rights in the Americas, Faculty Against Apartheid in South Africa, and the Rainbow Coalition. He is a member of the Board of Directors of the American Civil Liberties Union of Northern California.

In 1996, the Latino Law Association at the University of Michigan awarded him the Dr. Martin Luther King, Jr., Cesar Chavez and Rosa Parks award. He has recently been named the recipient of the Scholar of the Year Award by the National Association of Chicana and Chicano studies.
