About the Authors

Bradley Bates is Director of Intercollegiate Athletics at Miami University in Oxford, Ohio, where he presides over a department that made back-to-back football bowl game appearances for the first time in nearly thirty years while capturing conference championships in women's cross-country, ice hockey, baseball, men's and women's basketball, volleyball, men's and women's swimming and diving, soccer, tennis, softball, and synchronized skating.
