## Permission to Publish Agreement

1. **Parties:** This agreement is between the "Author(s)":

THE OFFICE OF SCHOLARLY COMMUNICATION, UNIVERSITY OF NEBRASKA-LINCOLN LIBRARIES shall have the right to determine the format, design, price, and distributor for the "Work."

5. **Royalties:** THE OFFICE OF SCHOLARLY COMMUNICATION, UNIVERSITY OF NEBRASKA-LINCOLN LIBRARIES shall pay the "Author(s)" annually, as follows:

Payments shall cover the period from January 1 to December 31, and be made on or before April 30 of the following year, and include an accounting of copies sold and sums received.

6. **Termination:** This agreement may be terminated by either party upon sixty (60) days notice to the other party. Final settlement and accounting will be made according to the schedule in section 5 above.

7. **Retention of Rights:** The "Author(s)" retain unto themselves and do not transfer their ownership or proprietorship of all rights in the "Work," including copyright, and may publish or dispose of them elsewhere without limitation.
