What's Going On in the LPE Learning Center?

Introducing the LPE Learning Center

'Connecting experts with those advising producers' on livestock environmental issues is the vision for the new Livestock and Poultry Environmental (LPE) Learning Center being launched this fall. The LPE Center, funded through the USDA Cooperative State Research Education and Extension Service (CSREES), utilizes a "customer-driven" approach (a national advisory team of stakeholders) to identify critical environmental issues specific to animal agriculture.

The center then turns to its outreach team, a multi-organizational group, to identify national experts and resources related to selected priority issues. Currently, the center has teams working in the areas of integrated nutrient management, capturing the value of manure, alternative technologies for manure treatment, and pathogens & pharmaceuticals. These issue based work groups will contribute to our monthly webcast seminars beginning in September 2006 (always the third Friday at 1:30 pm Central time). Additional information will be accessible through our Learning Center web site. Our first release of the web site, <http://lpe.unl.edu>, is available now with an excellent national resource listing targeting extension/education, regulations/policy, research, technical assistance, planning tools, and financial assistance.

The end-user of this information is ultimately the livestock or poultry producer. However, the LPE Center team is committed to supporting existing networks delivering information to producers. Our target audience is the advisor, whether they are ag organizations, public and private sector advisors, or those involved in public policy.

We invite you to subscribe to future Learning Center newsletters (see left hand column). We hope you will see benefit in staying abreast of activities of the Learning Center and sharing its resources, including this newsletter, with co-workers and clientele. National Resources Spotlight

EPA Ag Center is “First Stop” for Compliance Information

Environmental regulations related to agriculture have greatly increased in complexity. As a result, producers and their advisors need access to information about compliance. To address the need for a single point of contact for information, the US Environmental Protection Agency (EPA), in cooperation with USDA, created the National Ag Compliance Assistance Center.

The Ag Center, directed by Ginah Mortensen, is experiencing increasing demand for information:

- The toll free number has more than doubled over last year.
- The Ag Center has already distributed over 80,000 documents (all free of charge) through the first half of the year.
- More than 1800 subscribers are signed up for the free email News Service.
- The Ag Center website has already seen more “user sessions” (>100,000) on the website than all of last year.

The audience accessing Ag Center resources is shifting. “For the first time, the most common type of requestor is farmers, ranchers and producers, followed by extension agents”, says Carol Galloway, senior analyst with the Ag Center, “In the past, the most common requestors have been ag businesses and EPA offices.” The Ag Center’s main focus is on compliance assistance, however information about pollution prevention practices and technologies is also available.

Frank J. Humenik, 68, died Tuesday, March 28, 2006.

Frank was born in Brooklyn, New York on May 26, 1937. He received his PhD from Ohio State University, was a Professional Engineer and was named an ASAE Fellow. He was a Professor of Biological and Agricultural Engineering and served as Coordinator of the National Center for Manure and Animal Waste Management at North Carolina State University.

The LPE Learning Center team wishes to dedicate this newsletter to Frank, a co-investigator for the project. He was a respected leader, peer and friend. His commitment to outreach and extension programs as well as national leadership for animal manure issues impacted many of us who work in this issue area. The ideals in which Frank invested
