## SPRING HIGHLIGHTS IN THE VINEYARD

Following a relatively mild winter, weather this spring has been highly variable throughout the state. Unfortunately, the roller-coaster ride of fluctuating temperatures – a series of warm days followed by precipitous drops in temperature – has caused bud, cane and in some cases, trunk damage. As a general rule, young vines are more vulnerable to winter and spring cold temperature damage than are old, established vines. However, cultivars such as deChaunac and Lacrosse, to name a couple, tend to fruit quite well on secondary buds, so in many cases a modest-to-good crop may still result. Extent of damage and crop reduction will vary from location to location and only time will tell as to whether or not the late frosts and freezes will significantly diminish yields in Nebraska vineyards.

Precipitation has also varied considerably throughout the state. Some areas were blessed with abundant snowfall (well, at least more than in recent winters) and many have experienced several nice rains. What the future will bring in terms of moisture is yet to be seen. If abundant rains occur, it will be imperative that a diligent spray program be followed. Dr. Mike Ellis, Ohio State Plant Pathologist who was featured at our 2002 Fall Workshop on Disease Management, has repeatedly made the point that attention to early disease management will truly “bear fruit” (disease-free, that is!). For guidelines regarding spray timing, rates and chemical selection, review the Midwest Commercial Small Fruit and Grape Spray Guide – 2004. In addition, as always read and follow label directions.

We look forward to receiving your reports of both successes and problems in your vineyard. We hope that we will again have high quality fruit production and luscious Nebraska wines from the 2004 vintage.

## WINTER INJURY and Spring 2004

As Tim Martinson, Extension Specialist with the Finger Lakes Grape Program said following the disastrous 2003 season experienced by New York grape growers, “Winter injury is not the end of the world”. In spite of bud mortality of 90% or more, many growers harvested modest crops of 1 to 2 tons per acre – certainly this is not a profitable enterprise if sustained at that level over several years’ time – no doubt the recent late freezes in Nebraska vineyards will drastically reduce or eliminate yields in 2004, but depending on cultivar, location, severity and length of the cold temperature event, vineyard site characteristics and subsequent weather, it is possible that low to modest yields may still be achieved.

We will attempt to monitor the impact of the damage as it influences vine and crop development and ultimately fruit yield and quality. As Martinson also said, “Difficult years produce a lot of learning” – let’s hope we can learn as much as possible from the weather events of Spring, 2004.

## **FROM THE NWGGA BOARD!**

Besides watching our grapes begin to bud and leaf out, the NWGGA Board and Committees have several new initiatives happening as well. There are lots of new things to share with you:

- **Welcoming our new Board members:** We have already met twice to bring our new members, Max McFarland, VP; Barry McFarland and Jackie Hopkens, Board members, up to date with the ongoing activities. Thanks again to Teresa McFarland, Terry Ryan, and Carol Ringenberg for all their hard work!
- **Welcoming our new Committee chairpersons:** There have been some changes to our committees as well. Barry McFarland is going to take over for Eric Nelson on the Marketing Committee and Rick Barnett will be assuming Tim Hrdlicka's chair position on the Web Site Committee. Thanks to Eric and Tim for all of their hard work in the past as chairmen!
- **More changes to NWGGA's structure:** One of the goals of the Board this year is to work on revising the current committee structure to make our organization more responsive to the needs of its members. Several ideas have been suggested including having separate committees (councils) so that we can focus on the needs of our grape growers and wineries separately. The existing committees would be worked into the structure of these councils based on their primary focus. It was also suggested to divide the state into regions and have a representative from each region. These ideas and others are still being worked through and it will require changes to the bylaws. If you have any suggestions, please forward them to a member of the Board.
- **Development of an NWGGA newsletter:** Members continue to express their concerns and confusion as to what our organization is doing for them. (We really do listen!) As such, the Board has made the decision to take on its own newsletter to keep its members informed since many of you do not have web access. This newsletter will be sent out to members after each board meeting. NWGGA will continue to support the VineLines, as it is an excellent educational resource for members. However, members will now receive a brief newsletter summarizing Board and Committee activities and featuring educational and promotional events in the very near future.
- **Improvements to the NWGGA website:** The website is currently being revamped to hopefully be less confusing to those using it. We have not gotten a lot of specific comments about how to improve it, but the website committee is using other grape grower websites to make some changes. We hope to have it back up and working in a couple of weeks! - **Membership changes:** NWGGA members now have 4 categories of membership available to them. - **Increasing income to the organization:** This was a goal defined by last year's Board. With the assistance of some dedicated members, we have raised some additional dollars to help support our organizational costs via the trade show at UNL's 2004 Spring meeting and the Silent Auction (Kudos to Max and Holly!). We are currently working with other members who have helped us tap into some alternative agricultural grants through the Governor's office and we will be working on applying for some available marketing grants in the near future.

**We need your help!** Right now, we are counting heavily on a small number of dedicated members to accomplish this and other tasks as we try to move the grape and wine industry in Nebraska forward. We will be contacting those of you who indicated your willingness to volunteer to determine where you would like to help.
