## 11th ANNUAL NEBRASKA WINERY AND GRAPEGROWERS FORUM AND TRADE SHOW AGAIN A HUGE SUCCESS!

### Pre-Conference Workshops also Well-Received.

For the fourth year in a row over 350 attendees enjoyed the excellent presentations and activities of the Annual Nebraska Winery and Grape Growers Forum and Trade Show. Featured speakers were **Dr. Todd Steiner**, Ohio State University Enologist, and **Dr. Mike Ellis**, Ohio State University Plant Pathologist. The Conference was formally opened by welcoming remarks by University of Nebraska Vice President and Vice Chancellor of the Institute of Agriculture and Natural Resources **Dr. John Owens**, followed by supporting comments by **Dr. Mark Lagrimini**, Head of the University of Nebraska Department of Agronomy and Horticulture. During the Opening First Day Session, Dr. Steiner's keynote presentation was entitled "Quality Matters: Critical Parameters in the Production of a Quality Table Wine", which was followed by a second keynote address entitled "Critical Periods for Disease Control on Grapes" presented by Dr. Ellis. **Dr. Donald Rundquist** then presented "The Nebraska Vineyard Mapping Project" (see page 3 for details). In the second day's concurrent Viticulture and Winemaking sessions, Mike Ellis presented "New Developments in Grape Diseases" and "Managing Fungicide Resistance Development in Grape Diseases", while Todd Steiner spoke on "An Overview of Several Enology Studies at the Ohio State University/OARDC" and "An Update on the Ohio Quality Assurance Program". This latter presentation was followed by a panel discussion on the "Pros and Cons of a Quality Assurance Program for Nebraska Wines". Other topics that elicited positive comments and stimulated considerable interest on the part of the attendees included "An Interactive Grape Discussion" (Jim Schild), "Ten Years of Cultivar Evaluation" (Paul Read), "Cluster Removal Project" (Jim Hruskoci) and "We all Need to be a Little More Fruity" (Connie Reimers-Hild). A legislative update (Trish Lengel) and comments from representatives of the Nebraska Liquor Control Commission (J. Van Ackeren, D. Johnson, M. Wanser) and Tax and Trade Bureau (B. Richards, S. Abeyta).

Among the numerous positive comments noted in the conference evaluations included "Excellent Data" (Steiner), "great speaker" (Ellis), "budbreak and winter hardiness information is extremely valuable", "Schild's interactive presentation 'best ever'", "Steve's talk excellent", "enjoyed the introductory sessions on Thursday" and "liked the new growers session on Thursday". The latter comments refer to the "Fundamentals of Viticulture" and "Winery Challenges and Opportunities" workshops held on Thursday afternoon preceding the Forum. ### In Memoriam—Clare Wunderlich .June 21, 1949—March 16, 2008.

## The Nebraska Vineyard Mapping Project

Funding from the U.S. Environmental Protection Agency, via the Nebraska Department of Agriculture has allowed development of the Nebraska Vineyard Mapping Project. The overall goal of the activity is to create a web-based pesticide sensitive crop locator in order to increase compliance with pesticide laws and regulations. Compliance should be facilitated by making useful, location-specific information, such as maps and aerial views, available to applicators by means of Internet delivery. Project objectives are to: 1) construct a database of Nebraska vineyards, including pertinent information such as the geographic location of each vineyard; and 2) create a web-based Internet mapping capability to provide the spatial distribution of vineyards in the state along with a tool for growers to input new information. Once the prototype system for vineyards is operational, project leaders will seek input from growers of other pesticide-sensitive crops.



The vineyard mapping project is being conducted under the joint aegis of the Center for Advanced Land Management Information Technologies (CALMIT), a unit of the School of Natural Resources, and the Viticulture Program of the Department of Agronomy and Horticulture. Both groups are part of the Institute of Agriculture and Natural Resources at UNL. The project team includes Mr. Craig Romary (Nebraska Department of Agriculture), Dr. Don Rundquist (CALMIT), Dr. Paul Read (Agronomy and Horticulture), Ms. Ting Chen (CALMIT), and Dr. Russ Soucek (Doane College and CALMIT Visiting Scientist).
