### **I. GENERAL ACADEMIC PROGRAM INFORMATION**

The educational administration collection supports the teaching, research and service activities of the entire university community. Its primary audience is the faculty, staff, and students of the Educational Administration Department in the College of Education and Human Sciences. The collections primary focus is support for graduate curricula for educational administration.

#### **Educational Administration Department**

For many years, Educational Administration was a department within Teachers College. In fall 2003 Teachers College joined with the College of Human Resources and Family Sciences to create a new college called the College of Education and Human Sciences.

The department's broad purpose is listed on each page of the Educational Administration web site: "preparing tomorrow's educational leaders today." The instructional and research interests of the department are reflected in its professional mission of contributing to the improvement and excellence of the education field from elementary school through higher education.

Undergraduate degrees in educational administration are not available. However, the department offers Ed.D., Ph.D., M.Ed., and M.A. degrees as well as certifications/endorsements. Many of the courses can be taken either on campus or via distance. Consequently, many students across the nation, and some international students, are enrolled in classes or degree programs in the Educational Administration Department.

#### **Selected Research and Outreach**

**Bureau of Educational Research and Field Services** – The Bureau provides assistance to Nebraska school districts and policy makers.

**Center for the Study of Higher and Postsecondary Education** – The primary purpose of the Center is to conduct research related to academic leadership, faculty development, and trends in higher education. It also provides practicum and internship opportunities for students enrolled in the department's programs in higher education. In addition, the Center conducts seminars, conferences, workshops, and other activities aimed at improving the knowledge and skills of faculty and academic leaders.

**3-D Project for Early Childhood and Early Childhood Special Education: Extending Principal Support for Integrated Services to Children Birth to Five Years of Age** – This project is funded by the Nebraska Dept. of Education and implemented by the Dept. of Educational Administration. Its purpose is to support principals in the development of exemplary inclusion programs and in integrating schools, families, and communities.

Additional opportunities – Educational Administration faculty edit the *Journal of Women in Educational Leadership* and produce the Women in Educational Leadership Conference.

#### **Library Collections**

The University Libraries has committed to acquiring and collecting a wide range of resources to support the educational administration programs. Other collection development policies that

support the teaching and research of the Educational Administration Department include Teaching, Learning and Teacher Education and Educational Psychology as well as the Colleges of Business, Architecture and Law.

The Department's primary area of interest is the United States with some interest in other geographical areas as well.

#### **III. CHRONOLOGICAL COVERAGE**

The primary instructional and research interests of the Department are focused on current educational issues. However, materials of a historical nature are selectively purchased.

#### **IV. IMPRINT DATE**

Primary emphasis is on current and recently published materials.

#### **V. FORMAT/TYPE OF MATERIALS**

Most materials acquired are monographs, journals, serials, and reference works. Print, online, and databases formats are the most prevalent formats. Generally, journals are preferred in electronic format, when they are available.

#### **Electronic Databases**

The University Libraries have acquired a number of electronic databases which support educational administration and related areas. The primary databases and electronic resources are ERIC, Educational Administration Abstracts, Education: A Sage Full-Text Collection, and Education Index Retrospective. In addition, Academic Search Premier, Business Source Premier, JSTOR, PsycINFO, and Web of Science index some journals of interest to educational administration.

#### **VI. LANGUAGES**

English is the preferred language for materials collected at all intensity levels. Non-English materials are collected selectively. Translations are preferred to non-English materials.
