

President's Message



Haven House has been selected as NEOPA's community outreach project for this year. Haven House services northeast Nebraska families but is a branch of the Nebraska Domestic Violence Sexual Assault Coalition. This coalition is a statewide advocacy organization committed to the prevention and elimination of sexual and domestic violence. This non-profit agency provides crisis intervention and support services for domestic violence and sexual assault victims.

Our focus this year is on the school-age children who are directly affected by abuse. We ask that you join us in helping the children serviced by the Haven House agency. They are in need of special school-related supplies, i.e., book bags, pencil cases, calculators, computer discs, protractors, compasses, or gift cards to department stores such as Target and Wal-Mart.

WEOPA members will collect items like those listed above, or monetary contributions, at the <u>Fall Workshop</u> in Wayne. They will then be presented to the agency to be distributed to needy families. <u>Any donation would be most appreciated</u>.

Prior to my employment with LPS, we owned our own construction company doing finish grading for new construction. I also



Top Tips for Managing Your Time

Time is precious, and the eight (or ten) hours we spend at work each day typically aren't enough to get everything done. Here are a few ways to make better use of your day:

Plan your day the night before.

After you've wound down from the day, take a minute

After you've wound down from the day, take a minute or two to look over your schedule for the next day and the rest of the week. Make sure tomorrow's list of things to do contains everything that has to get done.

Overschedule a little.

Busy people tend to be more productive. (I know I'm more productive when I have a busy day when I have a million things on my to-do list.) If you pack your schedule with a few extra items, you might just surprise yourself and get them accomplished.

Prioritize.

Organize your day so that you do your most difficult or important tasks first, when you've got the most mental energy.

Work with your energy flow.

Some people are morning people; and some could work through the night and never think twice about it. If you're more awake after lunch, then make sure your afternoon is packed with the important stuff.

Align your time with when you're needed.

If your boss comes in at 7:00 a.m. and works twelve hours straight, you can't be there to help out whenever he or she needs you (unless your firm

pays overtime and you don't mind spending those extra hours at the office). But if your boss needs you more from 8:00 to 4:00 than from 9:00 to 5:00, ask if you can adjust your hours to better suit your boss's needs. You might find that you're more productive from 8:00 to 4:00, or from 10:00 to 6:00, than from 9:00 to 5:00.

Don't cry over spilled milk.

If an assignment doesn't work out, or if you have to redo something, get over it and move on. Time-management experts say a drawn-out mourning period only serves to squelch your productivity, leaving you with more work to do and less time to get it done.

Schedule smart meetings.

Try to schedule twenty- to thirty-minute meetings that back up onto something important—like lunch or the end of the day. Time-management experts say the rumbling of stomachs and our desire to get home at the end of the day are powerful motivators.

Stay organized.

If you don't know where things are, you'll waste minutes or hours each day trying to find them—which adds up to lost days over the course of a year. Several times a week, make organizing your workspace the last thing you do before you shut off the lights.

NAEOP Liaison Final Report July 2006

In the middle of a heat wave, 27 Nebraska ladies ventured to sunny Dallas, Texas, for the 72nd Annual NAEOP Conference and Institute. The trek began as early as July 14th

for some and all were present by July 18th. Of the 27, 7 were first-timers, 6 served as delegates in Advisory Council, 4 were honored at the PSP banquet, and 2 were installed at the Installation Banquet. Words

to describe this conference would include, hot, educational, busy, room issues, hot, fellowship, friends, hot, inspiring, tiring, and, oh yes, hot. Did I mention it was hot?

Deb Ryan (05-06 Elementary Council Chair), Lisa Morehouse (06-07 Administrative Council Chair), and I (06-07 Central Area Director) attended the 05-06 NAEOP board meeting all day on Sunday, July 16th. I would classify that experience as educational. Lisa and I attended the 06-07 NAEOP board meeting all day on Monday, July 17th, having our first experience standing at the microphone to give our reports. It amazed me how supportive our fellow board members and advisors were throughout the process.

While we were in the Monday board meeting, some of our Nebraska ladies attended Institute classes with an array of very interesting topics. Institute classes continued on Tuesday morning while others of our group attended the Kennedy Assassination tour. (It was discovered on the tour that they really do have fire ants in Texas.)

More Institute classes, as well as briefings, were held in the afternoon with a variety of topics. - 1. Members should be contacted after they are put on a committee. Members should also be given instructions on what they need to do. No motion was made. Recommendations were made for directors to do a better job of communicating with their committees.
- 2. Make NAEOP guidelines and applications more "accessible" on the Web site. No motion was made. Since the awards and scholarships are only available to those with a connection to the organization, it was decided we don't want it to be as accessible to those who are not eligible due to lack of affiliate sponsorship.
- 3. Establish an Incentive Award for a "Special Needs" student. Motion #1: NAEOP establish a \$500 award for a special needs individual for attaining a goal effective 2008. Motion passed. Motion #2: NAEOP establish an affiliate sponsored \$500 scholarship for a higher functioning special needs student to attend college, a vocational or life-long learning workshop to be effective in 2008. Motion passed.
- 4. Marian T. Woods Scholarship. No action was taken. The study group recommended a contact phone number be available for questions and that affiliates promote the scholarship within their state including contacting school guidance counselors.
- 5. Propose a bylaw change in Article III Membership Section 4 by adding "or an active member of an affiliate association." A motion was made and passed.

Elections were held and for the first time I

Advisory Council Report NAEOP Conference July 19, 2006

One of the duties of the NEOPA president is to be a delegate to the NAEOP (National Association of Educational Office Professionals) Advisory Council at the national conference. The NAEOP Advisory Council is made up of delegates from each affiliate. NEOPA is an affiliate of NAEOP, just as our local associations may be affiliates of the national organization, (NAEOP). It was my pleasure to represent NEOPA at this meeting in Dallas this year.

The Advisory Council is the voice of our local and state affiliates. Each year at the national conference, before the general sessions begin, the Advisory Council meets to review suggestions from the affiliates. This year, there were five submitted proposals.

There were 94 delegates present at the Council meeting. The delegates move into groups to review each proposal. The groups, made up from delegates from around the country, work together in 30-45 minute sessions to either make a recommendation or make a motion to be proposed at the NAEOP general business session, which begins on Thursday. Two of the groups forwarded motions to this general assembly. The other groups gave recommendations to the NAEOP Board of Directors to either forward on to a committee or to review at their next meeting in January.

Two motions that were passed at the Advisory Council and the general sessions dealt with a new scholarship and incentive award. The motion: "I move that NAEOP establish an affiliate sponsored incentive award of \$500 to be awarded to a high school special needs student who has overcome many difficulties to accomplish their Individualized Education Plan (IEP) goals and objectives effective 2008." Motion passed. Another motion: "I move that NAEOP establish an affiliate sponsored special needs scholarship award in the amount of \$500 annually for a high school special needs student to attend college, vocational school, and/or to apply for life long learning skills workshops. This would become effective in the 2008 budget year." Motion passed.

I happened to sit on this group. The original recommendation was made by a NAEOP member in New York. The New York state association had recently put this type of scholarship in place, and they felt it appropriate for the national organization to

follow suit. During the discussion, after the group overwhelmingly agreed by consensus to make a motion, we consulted with Dr. Jon Hall, NAEOP's parliamentarian. It was he who suggested we make two motions, as we were really addressing two different items. So,

it was agreed to present a scholarship and an incentive award in two separate motions. What a great learning process this was. Parliamentary procedure in action!

Another motion forwarded to the general business session dealt with a Bylaws change. Motion made: "I would propose a Bylaw change in Article III Membership Section 4 by adding "or an active member of an affiliate association." Article III Membership Section 4 would then read: Active membership shall be open to all persons actively employed as office personnel in an educational system or organization related to education or an active member of an affiliate association. The Active classification shall include those who pay dues on an annual basis and those who have paid life dues. An active member shall have the privilege of attending conferences, meetings, institutes, serving on committees, voting on all matters of the Association, and may hold office. (Submitted by Wyoming AEOP)

The entire process is interesting and rewarding. The delegates learn about each other, but also learn about parliamentary procedure and about our association and how we can make it better.

Another item of business that the Advisory Council is responsible for is to elect two people to each of NAEOP's standing committees. There are also members elected to these committees at the general sessions. The NAEOP Board of Directors have committees to help them in their duties through the year just as we do at our state and local levels.



NEOPA Student Scholarship Guidelines

Nebraska Educational Office Professionals Association Student Scholarship Guidelines

The members of the Nebraska Educational Office Professionals Association (NEOPA) annually award a scholarship to a qualifying graduating student who has completed a major course of study in the area of Business Education in a Nebraska high school or may currently be pursuing such a course of study in a post-secondary institution of higher learning.

Guidelines for awarding this scholarship will comply with the requirements for the Marion T. Wood (MTW) Student Scholarship awarded nationally so that the recipient will be Nebraska's entry for the MTW Student Scholarship. In the event that a local association has already submitted this recipient's name, the alternate will be NEOPA's candidate for the MTW Student Scholarship.

Eligibility

- Graduation from a Nebraska high school or its equivalent, i.e. GED.
- Completion of two or more business education courses (four semesters) from among the following: computer classes, keyboarding, typing, shorthand, accounting, office practices and procedures, and/or bookkeeping.

Application Process

The candidate must complete the application and the biographical information form provided by NEOPA. The application must be keyboard generated.

If a Graduating High School Senior, the application must include:

- A one-page biographical sketch on "Why I Am Choosing an Office-Related Career or Vocation".
- Three (3) letters of recommendation:
 - One from a principal, counselor or other administrator which describes the student's character, personality, initiative, and home background
 - ♦ One from a business education teacher
 - ♦ One from a non-family, non-educational office professional member.
- An official high school transcript indicating class rank at the end of the junior year.

If a **Higher Education Student**, the application must include:

- A one-page biographical sketch on "Why I Am Choosing an Office-Related Career or Vocation".
- Three letters of recommendation:
 - One from an advisor or counselor who can describe the student's activities/leadership record and the student's character, personality, and initiative
 - ♦ One from a former teacher or former/present employer
 - ♦ One from a non-family, non-educational office professional member
- An official college transcript.

Applications for this award must be postmarked by January 2, 2007.

Submit the original and two (2) photocopies of the application and support material. Materials will not be returned.

Scholarship Determination Process

Award of the scholarship is based upon academic achievement, financial need and initiative of the student.

The scholarship amount will be determined according to available funds and will be awarded annually in the spring. It will be awarded in the amount of \$1000.00 for the 2006-2007 school year. The applicant must have applied for admission to a higher education institution. The course of study will prepare him/her to enter an office-related profession, preferably in the field of education. If the recipient is unable to enroll in an institution of higher education by the fall term of the year he/she is selected, the scholarship will be deemed forfeited and the award will be given to the alternate. All applications will be kept until enrollment of the recipient has been verified.

Judges selected by the NEOPA Scholarship Committee will determine the award winner and the alternate. The recipient's school will be notified prior to the school's awards assembly and the recipient will be invited to the Spring Conference where the NEOPA Scholarship Certificate will be presented.

Two payments of \$500.00 will be made by check, one per semester, to the institution verifying the recipient's enrollment. It is the responsibility of the recipient to submit the required information to the NEOPA President for payment.
