Parking Advisory Committee

UNOPA Representative: Bernice Goemann, (Conservation and Survey Division)

This committee reviews and makes recommendations for the UNL parking facilities. Meeting once a month, each representative serves a threeyear term.

Some of the accomplishments for 1984-85 included:

-establishing a subcommittee to review the Parking Appeals System -reviewing the UNL parking bond

issue as presented and approved by the Board of Regents

-reviewing the preliminary report on automation of parking permits and parking management

-recommending an addition to the regulations to cite vehicles which are not properly registered, despite having a valid permit

-recommending that no action be taken on the Guaranteed Parking proposal and that it be tabled until later.

Parking Appeals Committee

UNOPA Representative: Anne Mulligan, (Telecommunications)

Meeting twice a month during the academic year, this committee hears appeals on parking violations of students, faculty, and staff. The committee can uphold, dismiss, or change the violation according to the UNL Parking and Traffic Regulations. Representatives serve a three-year term.

Campus Safety Committee

UNOPA Representative: Linda Maser, (Personnel, Division of Environmental Health & Safety)

This committee meets every other month during the academic year to discuss safety concerns and make recommendations to the Vice Chancellor for Business & Finance.

During the 1984-85 academic year, the following topics were

-UNL Fire Safety Plan: special fire drills are conducted in various buildings on a regular basis to improve evacuation time

-Bicycle Safety: recommendations have been submitted for a bicyle safety/regulations pamphlet to be distributed to those who ride bicyles on campus

-Loss Control Activities: there has been concern about and an effort to improve safety practices at certain units at the Mead Field Lab, research and extension centers outstate, and on UNL East Campus.

-Campus Lighting: Physical Plant/Grounds are experimenting with various types of lighting around campus with the goal of providing enough light for safety while still providing aesthetically pleasing surroundings.

-Tenth Street Crossing(s): recommendation to the city traffic engineer to monitor 10th street traffic to see if a walk light should be installed.

UNL Campus Police Committee

UNOPA Representative: Jan Wacker, (Division of Continuing Studies)

The UNL Campus Police Committee consists of two faculty members appointed by the Faculty Senate president; two students appointed by ASUN; one administrator, one UAAD member, and one UNOPA member appointed by the Chancellor.

The committee assists (1) in the determination of codes of ethics in the enforcement of campus security rgulations and policies on violations thereof; and (2) in an advisory role in the selection and review of the chief polic officer analogous to the faculty input on administrative evaluations and reviews.

Meeting during the months of September through May, the members of the committee serve two- or three-year terms. During this past year, questionnaires were sent to staff members on campus asking for their concerns and suggestions for UNL campus security.

Campus Representation

UofN Credit Union Board of

Directors

UNOPA Representative: Linda Arnold, (ARD/IANR)

The Board of Directors of the University of Nebraska Federal Credit Union meets monthly to oversee the Credit Union by reviewing the policies, investments, loan and interest rates, and the management staff as well as the budget for the Credit Union Office.

Representatives are elected by credit union members for a two-year term. Arnold was re-elected in March and serves as secretary to the Board.

Credit Union highlights for 1984-85 include:

-remained competitive by paying market interest rates to savers and charging at or below market interest rates to borrowers

-assets increased in 1984, up 22 percent over 1983

-loans to members increased in 1984, up 47 percent from 1983 -gained 331 new members,

representing a 10 percent growth
-began offering Share Draft
Checking Accounts

-expanded savings accounts offerings by including Personal Money Management Account paying money market interest rates to members.

Chancellor's Commission on the Status of Women

UNOPA Representative: Kathryn Martin, (Publications Services)

The purpose of the Commission is to advise the Chancellor and other administrators on general issues pertaining to sex equity and on specific concerns of women faculty, staff, and students at UNL. The Commission plans programs and activities designed to recognize the achievements and contributions of women; secure information from appropriate UNL offices concerning the status of women at UNL; conducts opinion/attitude surveys to ascertain the perceived status and specific concerns of all groups of women at UNL; and provides opportunities for women on campus to exchange ideas and offer support to other women.

The activities this past year included: a faculty tenure/salary study; sex equity in the classroom seminars; pay equity informational programs; Tables for Six (for administrative women) and TABLE TALK (for C-line women) to network and discuss concerns.

C-line committee members included: Angela Grajeda, Susie Kreiter, June Osborne, Lynn Pester, Mary Shonerd, and Grace Sobotka. The newly appointed C-line representatives to the Commission are: Lynn Pester, Linda Rossiter, and Mary Shonerd.

U-Wide Fringe Benefits Committee UNL Fringe Benefits Committee

UNOPA Representative: Chery! Selvage, (Instructional Media Center, Div.of Cont. Studies)

U-Wide: As an advisory committee to the Executive Vice President for Administration, this committee creates and maintains an open line of communication between the University of Nebraska administration and employees. Representatives from all three campuses (UNL, UNMC, UNO) meet once a month to discuss problems, and to recommend changes or additions to the benefits package. This year a number of options are being evaluated on health and retirement benefits.

UNL: The function of this committee is to represent UNL faculty and staff on the U-Wide Fringe Benefits Committee, present questions, recommend changes or additions to the benefits package.

University Child Care Project Affiliation Committee

UNOPA Representative: Sandy Wolfe, (4-H Youth Development)

Being a newly established committee, this group is concerned with the pending loss of the Child Care Project on campus because of reallocation of space. The UNL administration, at present, has no plans to relocate the project so that it remains a part of the campus community.

The Committee takes the position that the provision of child care is a University role and responsibility and deserving of University support. It is the committee's intent to present this position to the UNL administration as the one they, too, should take.

The committee's task is twofold: 1) identify a broad base of support in the University community, including faculty, staff, students, and administrators, in order to present this issue as credible and worthy of serious consideration and action to the administration; and 2) locate a facility that is on or near campus with adequate space in which to house the Child Care Project.

Sue Tidball Award for Creative Humanity Committee

UNOPA Representative: Kathryn Martin (Publications Services)

The purpose of this committee is to recognize individuals who have made significant contributions to the development of a more humane, open, educationally creative, just, and caring community on the UNL campus. An annual award, this honor is named after Sue Tidball (1925-1976), who invested her life, energy, and spirit in human beings.

People are encouraged to nominate persons from all walks of life. This year's six nominees included two students, a professor, two administrators, and an instructor. Their caring contributions to the UNL campus were read during the Sunday evening presentation and a wine and cheese reception followed. Committee members organize the nomination proceedings, plan, organize, and carry out the awards presentation and the reception.

Two individuals were presented this award for 1985: Mary Marcy, a student who has worked extensively with the Union Board, especially on the Culture Center project; and M. Bradley Munn, UNL Affirmative Action/EEO Officer and Handicapped Services Coordinator, for his work with the handicapped on campus.

The purpose of this association shall be to elevate the standards of the educational secretaries and office personnel within the University of Nebraska-Lincoln to provide a finer understanding of the relationship between the University and the community so that ever increasingly efficient service may be rendered to our educational systems.

The Professional Growth area of UNOPA is concerned with member participation in the national professional standards certificate program, scholarships and awards, continuing education, and workshops. The following events in these areas took place in 1984-85.

PROFESSIONAL STANDARDS PROGRAM (PSP)

The PSP is a nationally-sponsored voluntary certification program. Achievement in the program is recognized by certificates issued to members who meet required educational objectives, acquire stated amounts of experience and participate in professional activities.

Joyce Graybill, president-elect of the state organization of NEOPA, guest speaker at the February meeting, informed the membership about the PSP program and how to get started. UNOPA member Audrey Schardt, served as the state chairman for PSP for 1984-85. Receiving her PSP certificate at the national institute and meeting in Bolse, Idaho, July 17, 1985, was UNOPA member Patricia Lehecka, secretary in the College of Journalism.

AWARDS AND SCHOLARSHIPS

The Boss of the Year Award was presented to Emily Trickey, Assistant to the Dean of the College of Journalism. Pat Lehecka, (College of Journalism), nominated her supervisor for this award.

Two \$50 scholarships were given to be used for tuition and/or books at an educational institution of choice. These awards are given to applicants not only for finanical need but also for performance in service to UNOPA and other professional organizations and community activities. Receiving the scholarships were Mary Buell (Agricultural Economics) and Jan Meisenbach (4-H Youth Development). Kay Smith Stephens (Dept. of Admin., Curriculum and Instruction) was chosen as alternate.

Professional Growth

The fourth annual UNOPAsponsored workshop was held March
7. Dr. Gordon Culver, Professor
and Head of Business Education,
presented the topic "Improving
Communication in the Workplace."
The two sessions were attended by
241 office personnel. A profit of
\$350 was deposited in the UNOPA
Foundation fund to be used for
future workshops and training
seminars for professional development activities.
