We've just returned from yet another successful ACUTA Winter Seminar, featuring interactive sessions devoted to Unified Communications and Emergency Management, with the added excitement of some big-name celebrities such as Yogi Berra also visiting the Palm Springs area. From our ICT celebrities—institutional and corporate affiliate members and new and veteran exhibitors—we learned all about the benefits of the integration of communications platforms as well as many of the trials and tribulations to avoid. We also gleaned much from the experiences of those who have already embraced emergency preparedness on their campuses. And we glimpsed what the Leg/Reg future holds for us as the Federal Warning, Alert, and Response Network (WARN) Act was unveiled.

I would like you to note well that during the Winter Seminar an important collaborative message was released from ACUTA, Educause, and Internet2, organizations that represent more than 2,200 institutions and organizations of higher education. The joint paper, entitled "Higher Education and Information Technology in the 21st Century," was sent to the transition team of President-elect Obama. The paper calls upon the new administration to address several critical higher education information communications technology issues, including:

- Support for broadband infrastructure deployment in both higher education institutions and the private sector in the economic stimulus package
- Privacy and security policies that strike the right balance between security concerns and preservation of the innovative capacity of higher education networks
- Support for ongoing development of the nation's cyberinfrastructure, at a level commensurate with its importance to the nation's future
- Provision of sufficient resources to the Department of Education to support the continued development of IT-enabled improvements in higher education

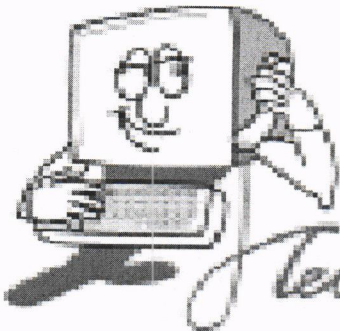

## It Sounds Scary, But “VoIP is Dead” Declaration Isn’t Cause for Worry

Don’t know how many of you find time in your busy schedules to monitor the “blogosphere,” but there has been a bit of a mini-debate going on in the last few weeks about the health—or lack thereof—of VoIP. This debate picked up momentum when one of the more influential bloggers gave some credence to the contention that “VoIP is Dead.” Since then, there has been lots of commentary on this idea, as you might imagine.

Rest assured that this crazy talk shouldn’t even remotely affect your network convergence plans, whether you’re bringing a unified network to campus for the first time or expanding an existing setup. It’s an interesting debate, but one that is peripheral to the larger issue of convergence.

If you look at VoIP in a vacuum, as a standalone application isolated from all the other things that IP enables, you can see the logic behind the VoIP-is-dead argument. Few organizations today would embrace network convergence for the sole purpose of being able to carry voice over the data network. That just isn’t the way the higher education world, or the corporate world, is converging.

Today, it’s more about EoIP—Everything over IP. And that includes voice. You have an entire laundry list of applications as well: conferencing, collaborative work, remote learning, unified messaging, location-based services, fixed-mobile convergence, and traditional voice telephony. These are all being merged for transport over a robust IP infrastructure.

Despite the overheated VoIP-is-Dead rhetoric, the debate is really a healthy thing at this point. It has become too easy to lump all the above-mentioned forms of network convergence under the misleading heading of VoIP, rather than focus on each application and the particular benefits that it brings to the organization and its users.

In the debate, we favor the side that says voice (VoIP) as one of the EoIP applications is quite healthy, but simply not as much of a novelty as it may have been a few years back. But that’s pretty typical as technology advances. If you go back a dozen years, e-mail was quite a novelty, and half a dozen years before that, faxing was Hot Stuff.

The EoIP progression is akin to the development of the iPhone, in which actual voice calls are only a small subset of all the things that handheld device, and others like it, can do for you. Just as hardly anyone buys a mobile phone today only for its voice capabilities (“Jitterbug” customers perhaps being the exception), moving to IP simply for the sake of voice is as unrewarding as it is illogical.

### Changes at the FCC

We are now at the beginning of the new administration and the transition is underway. Kevin Martin resigned his position at the FCC effective January 20—the same day that President Obama was inaugurated. On January 22 Commissioner Michael J. Copps was designated the acting chair while it is widely believed that Julius Genachowski will be nominated by President Obama to head the FCC. On his way out, Chairman Martin vigorously defended his record claiming “Success Over (the) Past Four Years in Protecting Consumers and Promoting Competition.” I am left wondering how the numerous mergers have promoted competition. On the other side, Martin’s last act was to raise concerns about the practice of cable operators who move channels from analog to digital only tiers at a higher rate, which can be viewed as protecting consumers.

The FCC is currently left with only 3 commissioners: Adelstein, Copps, and McDowell. Adelstein’s appointment has expired, but he can continue to serve until the current (111th) session of Congress ends. I haven’t found any news as to whether or not Obama plans on reappointing him. I find it of interest that McDowell has written to Chairman Copps stating that he is “greatly encouraged to know that you (Copps), Commissioner Adelstein, and I (McDowell) will be working together towards the goal of boosting employee moral, promoting greater transparency, as well as creating a more informed collaborative process and considerate decision-making process...” Later he talks about “delegating some authority back to upper and midlevel management” and “improving external communications.” Copps responded, thanking McDowell for his comments and indicating that some efforts are already underway such as improving the FCC website.

To me, the comments of McDowell speak volumes about the previous FCC under Martin, where many decisions were made in secret and information was not well communicated. The changes underway with an acting chair show how eager the remaining commissioners are to address the problems and bring real hope that we will be seeing an FCC that will be much easier to work with.

The comments about Julius Genachowski have been very positive. He is a former Harvard Law School classmate of President Obama, served as his top technology advisor during the campaign, and served on the transition team’s advisory board. He previously worked for the FCC as senior legal advisor to Reed Hundt while Hundt was chair of the FCC. He also has experience working at an Internet firm as well as several other businesses.

### DTV Transition Looms

Also on the radar is the looming DTV transition unless Congress decides to delay the implementation date. There is a lot of concern that many will not be prepared for the transition and will lose service on February 17 when the change is made. The funding for the coupons

for the converter boxes has run out, although it is believed that many have coupons that will not be used. Efforts are now underway in some areas to ask folks to turn in their unused coupons for use by others who really need them. In any case, Congress has yet to act and we are less than three weeks away from the deadline. The broadcasters are eager to move away from the extra expense of operating the duplicate equipment, and it is likely that many will lose service when the change is made.

As colleges and universities are tightening their travel budgets in response to the current economic downturn, the Board discussed the possible financial impacts that this may have on ACUTA at the upcoming seminars and Annual Conference. ACUTA is continuing to look for ways to reduce expenses and/or increase revenues.

ACUTA is also continuing to add value to its membership by providing a cost-effective and time-saving forum for interaction among technology providers and their current and potential customers. Other benefits include access to the listserv, legislative and regulatory alerts, audio/webinars, the Journal, eNews, and other sources of information.
