Report from Annual Conference in Atlanta

The 38th Annual Conference and Exhibition is now another page in ACUTA history. It reads much like other conferences in many ways, but was also unique. Not only was it a half day shorter, it was also our first annual conference to be held in the spring rather than the summer. Everyone seemed to enjoy the more comfortable spring temperatures in Atlanta. For the first time we co-located the conference with another group, ITERA, whose event began Saturday and ended on Monday. They attended some of our sessions and invited us to theirs. They also enjoyed visiting the vendors in our Exhibit Hall.

Even an outside observer could tell that the ACUTA network is a warm and inviting group of individuals who benefit from each other's expertise, respect each other's capabilities, and truly enjoy each other's company. 

Revisiting the iPhone in an Ever-Careful Way Who would have thought when Bob Metcalfe came up with Ethernet back in the early 1970s that it would still—nearly four decades later—be the basis for so much of what we do in networking and communication? It's like the Princess phone evolving as the core of all our voice telephony today.

But then, the early 1970-ish timeframe was also when optical fiber was developed, and that has certainly served us well in the intervening years. So with a tip of the hat to Mr. Metcalfe and his fiber-optic friends, we say thanks for coming up with technologies so versatile, and with so much evolutionary potential, that we can still be marveling 40 years later about the great things we can do with them.

On that note, we'll take up the topic of one of the latest Ethernet developments, Fibre Channel over Ethernet. FCoE, as the acronym lovers know it, is one of the newest breeds of storage technologies, and even as you read this it is moving through the standards process. FCoE's purpose is to enable network convergence and cost-effective storage area network (SAN) expansion in the data center.

The idea is to move native Fibre Channel traffic over 10-gigabit-per-second Ethernet, alongside standard network traffic. In this instance, in order to meet the demands of Fibre Channel, the Ethernet is a still-in-the-works enhanced Ethernet, with greater flow control, dynamic bandwidth allocation, and better communication between end nodes and switches, designed to overcome latency and packet loss issues.

The benefits touted by FCoE's backers, most notably Cisco, are seamless extension of Fibre Channel SANs, increased IT efficiency, unified management, and overall reductions in the total cost of ownership.

Other options have their defenders as well, who say that storage technologies such as iSCSI or InfiniBand (which we wrote about here way back in July 2003) could work equally well, particularly by using the same enhanced Ethernet that is still being worked on in the standards bodies. These folks say that while FCoE might have the edge on speed and power, it would also be more expensive than iSCSI.

So if changes to your storage network are in your short- or long-term future (should your budgets permit), now is the time to begin watching these developments closely. Some of your decisions will depend on how much of your data is "mission critical," as well as your existing data center infrastructures.

What's New with Social Networking at ACUTA?

We all know that the use of social networking tools is gaining wide acceptance in the business world, and ACUTA is no exception. We have created some new opportunities to follow ACUTA activities and network with other members via social networking tools, and we have created a new group within our committee structure to advise on how ACUTA and our members can use these tools more effectively.

LinkedIn is a social networking tool that is geared to professionals. It is designed to help its members expand and make better use of their professional networks. Member profiles essentially mirror a resume or CV, listing current and past employers, positions, consulting assignments, and other professional background. LinkedIn members have the opportunity to request references and recommendations, and they can indicate their goals in using the tool, such as new career opportunities, consulting offers, business deals, or getting back in touch with past colleagues or classmates.

We formed an ACUTA group on LinkedIn last October, with several goals in mind. We wanted to provide another forum for members to find and connect with other ACUTA members with similar interests, and allow members to ask questions and get feedback on issues. We also felt that LinkedIn would provide an opportunity to reach the younger generation of professionals who are used to communicating in virtual/online communities.

Joining the ACUTA group on LinkedIn is easy. If you don't already have a personal LinkedIn account and profile, go to www.linkedin.com and create one. Then sign in and click on the "Groups" link on the left side of your "Home" page, and select "Find a Group" in the "Groups Directory" box. You can then use the "Search Groups" option to search for and join the ACUTA LinkedIn group. The ACUTA staff will verify your ACUTA membership and approve your addition to the group.

More recently, we also created an ACUTA group on Twitter. Twitter is currently growing in popularity, allowing members to "follow" each other's current activities and share ideas via quick messages or "Tweets" that are limited to 140 characters in length. Advanced users also include Web links, photos, and other enhancements to their Twitter messages.

ACUTA is using Twitter to post informative updates on our conferences, programs, and services; new information added to our website; new resources available to members; and other updates suited to this brief format.

If you are interested in joining the growing list of ACUTA "followers" on Twitter, first create your own account at www.twitter.com. Then you can follow ACUTA by either doing a "Find People" search for "ACUTA" or by going to our public webpage, http://twitter.com/acuta, and selecting "Follow."

Finally, we have created a new Subcommittee on Social Networking, New Media and Web Resources with the express purpose of advising ACUTA regarding social networking tools, recommending solutions to create online communities and professional networks, and recommending Web 2.0 resources, tools and services that would be useful for ACUTA members. The subcommittee is getting started this spring, and we are actively seeking volunteers with expertise in this area.

FCC Appointments

Julius Genachowski has still not been confirmed as the new chair of the FCC. Evidently the confirmation is being held up until a new republican commissioner is selected to replace former commissioner Tate. Both appointments would then be confirmed at the same time. Since President Obama finally has his cabinet in place hopefully things will start to move.

Broadband for Everyone

The FCC has issued a Notice of Inquiry to gather information to be used to develop a broadband plan for the nation by next February. This plan will be finalized after the broadband stimulus funds have been allocated however given that the stimulus monies will not begin to address the whole problem the plan should be very beneficial in setting a direction for the future. The comments received as a result of this inquiry will be watched by the Legislative and regulatory affairs committee. Comments are due by June 8th.

Illegal Downloads

Most of us deal with the issue of illegal downloads, and there is an interesting development in the European Union concerning downloads. The EU is considering a telecommunications law that would separate dominant phone companies from their networks and increase coordination of broadband frequencies between countries. However, the bill also blocks government agencies from cutting off Internet service to a EU citizen. France is considering a bill to do just that by cutting service to anyone caught making illegal downloads three times in one year. Let's hope that the idea doesn't catch on here. I doubt that very many of us would want to deal with a government order to cut Internet service to one of our students.

Automated Calls and the Switchboard

On the ACUTA listserv an issue was reported about a switchboard being taken down by a large number of automated phone calls warning of soon-to-expire car warranty services. I looked into this to see if there was any recognition of the problem and found that there has been some action by state attorneys general. Some companies have been fined, although they do not acknowledge any wrong doing. I would encourage everyone to document the problem when it happens and get it reported

through your legal representatives. Please include some estimate of the damages. I remember being hit by one of these "attacks" a couple of years ago where the calls were being sent to all numbers in the DID block. We took over 18,000 calls in a one-hour period and had no use of our local trunking. Unfortunately we had very little information on who was sending the calls.

The FCC has an open meeting on May 13 with an item on the agenda regarding a report and order regarding porting of wireline to wireline and intermodal transport requests. Earlier the House Energy and Commerce Committee asked the FCC to change the timing for such porting requests from 4 days to 48 hours stating that wireless carriers can accomplish ports in 2.5 hours.

DTV Transition

The DTV transition continues, and hopefully we will see the end of it on June 12. There are some reports that not enough converter boxes are available although the waiting list for coupons has been cleared. 637 stations have already converted while 927 (a little more than half) will wait until June 12th to discontinue analog programming.

Board Report February

Riny Ledgerwood San Diego State Univ. ACUTA Secretary/Treasurer rledgerw@mail.sdsu.edu The Board of Directors and Committee Chairs met on April 18 in Atlanta immediately prior to the Annual Conference. The following are highlights from the meeting:

- The February 28, 2009 financial statements were approved.
- The March 31 membership recruitment update reports 22 new institutional members and 15 new corporate affiliate members attributable to the 2009 membership recruitment campaign, which is good progress on meeting our goals for the year.
- All of the committee chairs and the Executive Director submitted their year-end reports.
- The revised committee structure and final report of the Committee Structure Task Force were received and approved.
- A change in the Policies and Procedures was approved to allow the President the option of appointing a corporate affiliate member as chair of the Corporate Liaison Committee (formerly the Vendor Liaison Committee).
- The following committee chairs were appointed:
 - 1. Higher Education Advisory Panel: Patricia Todus, Northwestern University
 - 2. Legislative/Regulatory Affairs Committee: Wendell Barbour, Longwood University
 - 3. Publications: Dave Wirth, Princeton University
 - 4. Membership Experience: Jennifer Van Horn, Indiana Univ.-Purdue Univ. Indiana
 - 5. Corporate Liaison: Sharon Moore, Smith College
- Additional members were appointed to the Higher Education Advisory Panel, Legislative/ Regulatory Affairs Committee, Program Committee, and Corporate Liaison Committee.
- Buck Bayliff of PCR was confirmed as the Appointed Director-at-Large for 2009-10.
- The 2010 seminar topics were approved, with some recommendations for minor language changes to the seminar titles.
- The Board voted to nominate Walt Magnussen from Texas A&M University for the FCC Communications Security, Reliability and Interoperability Council (CSRIC).
- The Board discussed plans for the 2009 Business Meeting, which will be more interactive by incorporating a Q&A session with the committee chairs, officers and Executive Director, and roundtable discussions.
- The Board approved several cost-saving strategies for the remainder of the current fiscal year and the next fiscal year. These matters will be re-visited as economic conditions continue to evolve.
- The Board approved a recommendation for remote Web access to the Summit on Unified Communications and Collaborations in Denver this July 12-15.
- The Board approved an upgrade to the ACUTA membership database software, Web site redesign and Web 2.0 software acquisition to take place between now and February 2010.
- The Board held a discussion with ACUTA's new Data Analyst Dr. Michael Bowman of Murray State University, regarding his proposed research approach.
- The Board accepted a recommendation from the Publications Committee to discontinue the 5th issue of the Journal in alternate years, after the 2009 edition.
- The Board approved guidelines for listing of webinars and audio seminars offered by ACUTA corporate affiliate members at no cost on the ACUTA Web site.
- Matt Arthur provided an update on the negotiated rulemaking status for the Higher Education Opportunity Act, focusing on the P2P file sharing rules.
- The Board conducted the annual evaluation of the Executive Director.
