I hereby pledge myself to be true to the principles of the University of Nebraska Office Professionals Association.

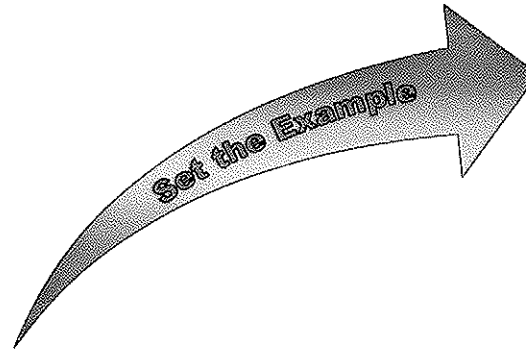
I will recruit new members.

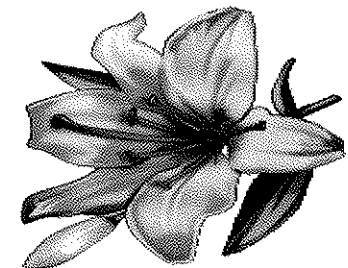
