EYEWITNESS TESTIMONY

The lead article in this issue of *Court Review* tests the knowledge of judges about eyewitness testimony against the extensive research data compiled by psychologists and others. For judges who would like to review the underlying research data in greater detail, we suggest this article from a past issue of *Court Review*. In it, three leading researchers review in detail the data showing what tends to make eyewitnesses more—or less—reliable. The article also compares the assumptions contained in eyewitness jury instructions commonly used against the research data and makes some suggestions for the consideration of the courts.
