Abstract


Juvenile maltreatment in homes is a large factor in today's incarcerated youth. Victims of child abuse and neglect are predominant in the foster care system. This issue has grown to where "1/4 of foster care alumni will become involved with the criminal justice system within two years of leaving care." (Anspach, 2018). These children who experience certain maltreatment while in foster care are at an increased risk of engaging in delinquent behavior. They often move out of the welfare system into the criminal justice system.

Key Points

•Children with a number of foster home placements are in need of special services and policies that provide the necessary resources for these foster children must be developed. •Children who experience maltreatment are at an increased risk of delinquency in comparison to those who experience no maltreatment.

•Research shows that anywhere from 9% -29% of maltreated children engage in delinquent behavior (Ryan & Testa. 2004). •Being incarcerated as a juvenile, increases foster youth's risk for continued involvement.
