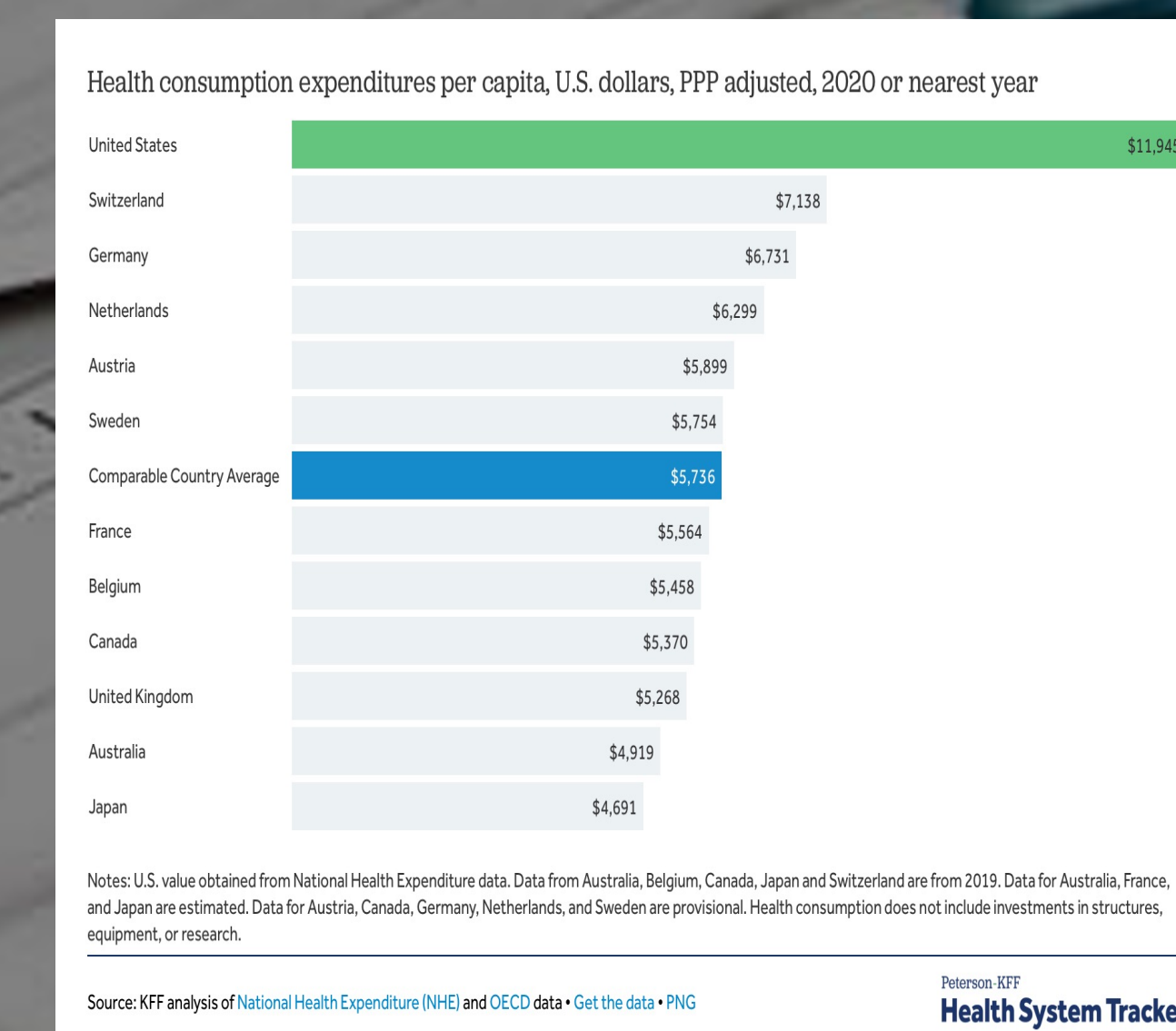


## Conclusions & Discussion
