The cycle of homelessness and jail Overenforcement and Warrants and arrests are quickly triggered by unpaid criminalization of homelessness fines and missed court dates. exposes people living outside to frequent police contact and citations for low-level charges. Increased obstacles and Longer periods in jail result from restrictions on release from jail the higher likelihood of pretrial make it even harder to find safe incarceration, vulnerability to harsher sentencing, and challenges housing, employment, and overall stability—leaving many of navigating probation terms. recently released people with no realistic options for avoiding homelessness.

FINDINGS:

¼ of families in shelters are living apart from one or more children (Shinn et al., 2018, pp. 118-119).

Higher risk of new health conditions, worsening conditions, experiencing violence/charges, malnutrition, extreme weather, premature deaths, no access to health insurance/health services (Hodge et al., p. 28, 2017)

There are plenty of ways for the government to help the homeless: eliminate the criminalization/arrestment of non-violent/quality of life offenses, create avenues for forgiveness of fees, fines, and offenses dealing with homelessness, and creating a better environment to support people without housing, and address housing and employment restrictions for those involved with the judicial system (Bailey et al., pp. 11-12, 2020)

conclusions & Discussion: Minimizing the amount of persons having to experience homelessness is key in fixing the problem. The homelessness and jail cycle needs to be challenged in order to be fixed. with the outlooks of things with COVID-19, police interactions has dropped significantly. This implies it can be implemented long-term. Without a solution, the homeless population continues to encounter health issues and the unforgiving cycle.
