## UNOPA Membership Committee Report

June 2, 1993

UNOPA membership at the end of the 1992-93 year is 278. This total exceeds last year by 16 members. The current membership is comprised of: 6 new associates, 40 new active members, 16 renewed associate members, 172 renewed active members, 21 retired members, 1 life time member, 18 honorary members, and 4 members whose status was changed from active to associate when they moved/left the University system. Also, several members rejoined this year after dropping membership in the past.

Throughout the year 170 letters were mailed to newly hired office/service personnel, and 184 letters were mailed to guests attending UNOPA's general meetings. A total of 1,897 mailings (including 262 UNOPA members from last year) were sent to University office/service personnel in our initial recruitment efforts. Letters were not sent to luncheon guests or new employees during May, 1993 as this is the end of the 1992-93 membership year. However, notes will be forwarded to the new Membership Director, Nelvie Lienemann, so that recruitment materials may be sent these people in mid-August.

The records regarding UNOPA members with CEOE and/or PSP certificates were turned over to the Professional Growth Committee. They are the ones who have and/or obtain the information on these certificates.

As of this date, we have 28 NEOPA (State) members and 27 NAEOP (National) members. A total of \$2,197 was collected this year for membership dues and sent to UNOPA's Treasurer, Mildred Holland, for deposit.

Today, I am providing the outgoing Executive Board and the New Executive Board copies of the final 1992-93 Membership Roster, lists of the current Associate, Retired, Lifetime, and Honorary Members, and a list of the National and State members. The Membership Committee's Income/Expenses for 1992-93 have been reconciled with the Treasurer's records. A final copy is being provided to the following people: Kathy Bennetch, President; Linda Pence, Recording Secretary; and Mildred Holland, Treasurer.

CONGRATULATIONS and GOOD LUCK are extended to Nelvie Lienemann, our new Membership Director. The Membership Committee records, files, and remaining supplies will be given to Nelvie when she returns from vacation in mid-June.

SPECIAL THANKS is extended to Kathy Bennetch, our President, and to the Executive Board. It certainly has been a delightful, learning experience for me and with everyone's encouragement, suggestions, and assistance my position as Membership Director was made much easier.


