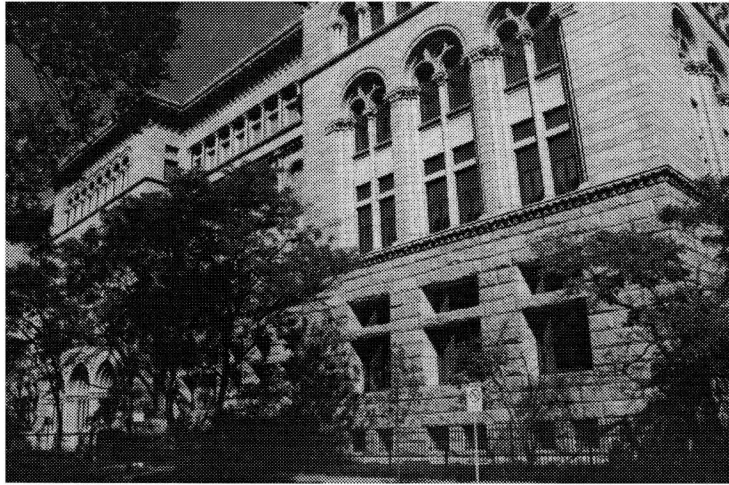

Submissions to *Documentary Editing* should be typed and double-spaced on letter-size paper. If mailed, the article/review must be printed using an easy-to-read font and size. An electronic version on 100MB zip disk or 3.5 floppy disk should accompany the printout. All electronic submissions on disk or via e-mail must be in WordPerfect or MicrosoftWord. If photographs, diagrams, or holographs accompany the document, please include each in a file separate from the text or send them as individual e-mail attachments. Scanned images must be in TIFF or JPEG format and at 300dpi or higher resolution. Any images submitted must contain all copyright information in order to provide proper captions. Authors should also expect to assist the editors in obtaining permission for printing such images in *Documentary Editing* prior to publication.

Documentary Editing (ISSN 0196-7134) is published quarterly (in Spring, Summer, Fall, and Winter) by the Association for Documentary Editing (ADE) and is provided free to all members. **Membership categories** are: Annual \$25, Sustaining \$40, Patron \$70, Student \$15, and Retired \$15. **Institutional subscription rates** are: Annual \$25, 2 years \$48, and 3 years \$70.
