Nebraska Seed Improvement Conference - 2011

The NCIA Staff and Board of Directors would like to invite all of the members of the Nebraska Crop Improvement Association (NCIA) and Nebraska Seed Trade Association (NSTA) to join us at the North Platte Sandhills Convention Center on January 17 -19 for the 2011 Nebraska Seed Improvement Conference. The annual conference brings together members of both Associations for educational presentations, business meetings, and interaction with colleagues. Excellent speakers and a trade show that will address issues that impact your seed enterprise will highlight the conference.

The conference will be formatted similar to last year (although the NuPride annual meeting will be moved back to Wednesday morning). It is condensed into one and a half days to accommodate those that only want to spend one night. The Product Action Sessions will all be held consecutively. This will allow each member to attend those that interest them or they may attend all of the sessions. **Your attendance of the conference will fulfill your continuing education requirement for the next three years.** The annual meeting will again be held at 11:00 with a buffet lunch to follow.

Tuesday morning Intellectual Property Rights lawyers from Jondel and Associates will explain what happens when genetic trait patents on seed crops expire. The Product and Actions Sessions will follow in the afternoon with time at the end of the day for any issues or resolutions to be brought forward on any seed crops.
