POD will hold its Fourth Annual Conference at the Shangri-La Conference Center near Tulsa, Oklahoma, with the theme "CURRENT PRACTICE AND ISSUES IN PROFESSIONAL DEVELOPMENT." This is the only notice you will receive. We hope that you will be able to attend.

The conference registration fee will be \$45 (\$55 for non-members). The full American Plan rate per person is \$39.93 per day. A few rooms are available for single occupancy at \$54.75 per day. Suites are also available. THIS YEAR IT IS IMPERATIVE THAT YOU REGISTER EARLY SO THAT YOUR PLACE WILL BE ASSURED.

Bus transportation from and to the Tulsa Airport will be available on November 5 and 8 for \$12 round trip. A bus schedule will be sent to registrants along with hotel registration materials. Remember, you can take advantage of "Super Saver" airline rates if you reserve flights at least 30 days in advance.
