Summary:

This is the first monthly report of the Medical Information and Intelligence Agency (MIIA), a small US Army intelligence agency. The report refers to General Orders 62, Headquarters, Walter Reed Army Medical Center, dated 24 September 1956, which set up MIIA as an organization subordinate to the Walter Reed Army Medical Center. The agency was created from "personnel formerly assigned to the Intelligence Branch and Library of the Medical Information and Intelligence Division, OTSG, as well as personnel from the OTSG Reference Library." As the sentence above states, MIIA was created using personnel formerly working in the Office of The Surgeon General, the chief of the Army Medical Service. Army medical intelligence originated as a small section in the Office of the Surgeon General in the early 1940s.

The report also states that Lieutenant Colonel James W. Dean, Medical Service Corps, assumed command of MIIA on 28 September 1956.

A. OFFICE OF THE COMMANDING OFFICER.

1. GENERAL

In accordance with the provisions of General Orders No. 62, Headquarters, Walter Reed Army Medical Center, dated 24 September 1956, the Medical Information and Intelligence Agency (9901.10 TU) was activated as a separate Class II Army Medical Service activity at the Walter Reed Army Medical Center. Command of the Agency was assumed by James W. Dean, Lieutenant Colonel, MSC, on 28 September 1956. Lieutenant Colonel Dean was relieved from assignment to the Office of The Surgeon General and assigned to Walter Reed Army Medical Center by Special Orders No. 191, Department of the Army, dated 25 September 1956. The Agency consists of personnel formerly assigned to the Intelligence Branch and Library of the Medical Information and Intelligence Division, OTSG, as well as personnel from the OTSG Reference Library.

B, INTELLIGENCE BRANCH.

1. COLLECTION.

a. Briefings.

(1) Personnel of the Branch participated in a total of 18 briefings of personnel from the Central Intelligence Agency; Office of the Assistant Chief of Staff, Intelligence, Department of the Army; Pan American Sanitary Bureau; Army Map Service; Department of Commerce; Department of Agriculture; National Library of Medicine; and the National Academy of Science.
